#### i. DIR-2024-3331-DRB-SPPC-MSP, 2252 N. Gloaming Way, APN: 4388006019 (CD 5)

The project proposes the demolition of an existing single-family home and swimming pool and the construction of a new single-family home with an attached garage, basement, swimming pool, deck, retaining wall with a maximum height of 10 feet, and ADU, which will be reviewed separately in an administrative manner. The project proposes to have a maximum Residential Floor Area of 4,498 square feet and is requesting a 20% RFA Bonus. The project proposes to have a maximum height of 30 feet on a lot of approximately 15,022 square feet. The project site is in Outer Corridor and subject to the Baseline Hillside Ordinance. The project site is downslope and Visible from the Mulholland Drive right-of-way. The project proposes the removal of five non-protected significant trees. The project proposes 912 cubic yards of cut, 156 cubic yards of fill, 758 cubic yards of export, and 0 cubic yards of import grading.

#### 8. Public Hearing: New Cases

#### i. DIR-2024-6050-MSP-DRB-SPPC, 3334 N. Berry Drive, APN: 2380015019 (CD 4)

The project proposes the major remodel and addition of 2,024 square feet to an existing single-family home; and a new retaining wall with a maximum height of 9 feet. The proposed additions have a maximum height of 27'6" on a site of approximately 14,524 square feet. The project site is in the Outer Corridor and subject to the Baseline Hillside Ordinance. The project site is downslope and Visible from the Mulholland Drive right-of-way. The project proposes 45 cubic yards of cut, 0 cubic yards of fill, 45 cubic yards of export, and 0 cubic yards of import grading. There are no proposed tree removals.

Grading – Cut: 45 Cubic Yards (CUYD), Fill: 0 CUYD, Export: 45 CUYD, Import: 0 CUYD Related Environmental: ENV-2024-6051-CE

## ii. DIR-2024-1234-SPPC-MSP-DRB-HCA, 6801 W. Mulholland Drive, APN: 5549005014 (CD 4)

The project proposes the construction of a new single-family home of 2,594 square feet with a maximum height of 15 feet on a vacant lot of approximately 7,763 square feet located on a Prominent Ridge, as shown on Map No. 12 of the Mulholland Maps. The project includes a

2-car garage designed as a tunnel, basement, swimming pool, deck, and one retaining wall that does not exceed 6 feet in height. The project site is in the Inner Corridor and subject to the Baseline Hillside Ordinance. The project site is upslope and Visible from the Mulholland Drive right-of-way. The project proposes 1,620 cubic yards of cut, 628 cubic yards of fill, 992 cubic yards of export, and 0 cubic yards of import grading. There are no protected tree removals.

Grading – Cut: 1,620 Cubic Yards (CUYD), Fill: 628 CUYD, Export: 992 CUYD, Import: 0 CUYD Related Environmental: ENV-2024-1235-EAF

**OPEN MEETINGS** - The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter jurisdiction of the DRB. The Chair of the DRB may allocate the number of speakers per subject, the time allotted on each subject, and the time allotted to each speaker. Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Mulholland Scenic Parkway Specific Plan Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department and the Planning Department Website. **TESTIMONY AND CORRESPONDENCE** - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to, or at the hearing. Any materials submitted to the Department become City property and <u>will not</u> be returned. This includes any correspondence or exhibits used as part of your testimony.

**PERSONS WISHING TO PROVIDE PUBLIC COMMENT:** When the Agenda item you wish to speak on comes up, please press \*9 to 'raise your hand'. Following the item presentation, Board staff will unmute those wishing to provide public comment and those who have 'raised their hand'. When called upon, you can begin to provide public comment for your allotted time. Staff will track your allotted time and give you a warning before the end of your allotted time, subsequently re-muting your line when your allotted time has concluded. Should there be any questions from the Board or Planning staff requiring your response, you will again be unmuted.

**REQUIREMENTS FOR SUBMISSION OF MATERIALS** – To ensure that the Design Review Board has ample opportunity to review written materials, members of the public who wish to submit written materials on agendized items should comply with the following:

Requirements for Submission of Materials for Members of the Public. Written materials may be submitted prior to the hearing via email to <u>Planning.MulhollandSPInfo@lacity.org.</u> Submissions on the day of the public hearing may not be more than two (2) written pages, including exhibits, and must include the case and agenda item number on the cover or first page of the attachment. Photographs do not count toward the page limitation. The submission must be provided to Planning staff prior to the start of the

hearing.

**Non-Complying Submissions.** Submissions that do not comply with these rules will be stamped "File Copy. Non-complying Submission." Noncomplying submissions will be placed into the official case file, but they will not be delivered to or considered by the Board and will not be included in the official administrative record for the item at issue.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW -** If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

### **Telecommunication Relay Services -**

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to- Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the CA is a telemarketer. If you hear, "Hello. This is the relay service..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
