Villa in Tel Aviv

As a principal of a two-person architectural design firm. We completed several concept designs and actual built projects in the short but sweet two-year lifespan of the company. I am especially proud of a 3,600 square foot modern concrete and steel Villa I designed in the upscale Ramat-Gan section of Tel Aviv. It was built for \$125 a square foot in 2001-2002. [The family loves the house, still.] [Though to be honest with you, they drove me crazy ... especially the wife.] It has been published in five glorious pages in a big glossy Israeli design magazine. Unfortunately I can't read a word of what they wrote about it.

Jewish Museum in San Francisco

I consulted with the Jewish Museum in San Francisco about how to tackle the problems of designing public exhibition spaces in highly irregular modern architecture. They had employed Daniel Libeskind to design the museum and there wasn't a right angle in the joint. I believe that I successfully introduced the staff to the issues involved in designing and mounting public installations within dynamic architectural spaces

Experience Music Project, Rock 'n Roll Museum 1998-1999

Digital Domain

Lead designer - 12 million dollar multi media kinetic theater comprising the guts of one of the discreet pavilions that makes up the Frank Gehry designed Experience

Music Project, Paul Allen's vanity Rock 'n Roll museum in Seattle, Washington. I worked under the supervision of Ed Ulbrich, Chief Creative Officer, at Digital Domain, 1998-99.

One of the toughest challenges was incorporating the ADA (Americans with Disabilities Act) requirements into a highly technical and constrained program within the confines of an irregular space. The project, ill conceived from the start, had floundered for years. I was one of a group of consultants brought in as part of a last ditch attempt to save the project. I alone was retained and put on staff for the 7 months. I did save the project, but it couldn't save itself. When the production of the dedicated programming content faltered, they replaced it with a Sci-Fi museum filled with artifacts from my husband's movies. Oh, the irony of it all.

As lead designer I was also responsible for architectural pencil renderings, which resulted in Paul Allen's approval and complete funding of the project.

I coordinated the design phase of the engineering and manufacturing vendors for the technical audio-visual and special materials, including the mechanical components of 2 kinetic theater chambers.

Restored the original house on Rivas Canyon Rd. in Pacific Palisades.

Built for his family by architect and famed furniture maker Avery Rennick (who bought the property from Will Rogers) in 1940, this charming salt box colonial home set on an acre of canyon gardens had suffered long years of neglect and abuse after its glory years, when it was the resident of Myrna Loy and later George Sanders (while he was married to Zsa Zsa Gabor). At the of 96, Rennick sought me out and gave me a token of his gratitude for having saved the building that others considered beyond repair.

Art Direction & Set Design for Feature Films: 1987-1991

I art directed and or set designed fifteen feature films, most of them lousy. Some of them were at Roger Corman's studio. I did, however, work directly with some terrific directors, production designers and art directors. Including: Catherine Hardwicke, Taylor Hackford, Bruno Rubeo, Fernando Scarfiotti, Ed Richardson and Wynn Thomas (all Academy Award nominees or winners) Don Diers & Dean Taucher to name a few. I always chose the team over the script; consequently I have excellent work references but crummy credits.

Disney Concert Hall

I inadvertently designed the schematics of Frank Gehry's Disney Concert Hall in downtown L.A. as my SCI-ARC Master's thesis project. To my knowledge, this is the only part of the project that remained unchanged in the six years of design development that went into the completed project.

I have never sought recognition for this coincidence until now, when I need to re-enter the job market in middle age. So, I guess you could say that I have some facility with the planning of urban public spaces. I will be happy to show it to you if you are really curious... It was inked on Duralene and reversed printed, “negative” style, back in the days when you did that stuff by hand.

Education

I worked as a Graduate Teaching Assistant in architectural history while completing a Masters in Architecture from the **Southern California Institute of Architecture** (SCI-ARC) in 1987 after finishing my Bachelor of Arts, in English and American Studies (magna cum laude) from **UCLA** in 1982.– selected by architectural historian Prof. Margaret Crawford.- now at Harvard and recently at UC Berkeley.

I have been a guest critic for the environmental design department at Art Center College of Design in Pasadena.

I wrote a published article in a construction trade publication for Jim Weiner, AIA, LEED AP in 2006, about how to hire a LEED AP consultant. – I attended a seminar and somehow got hired by the expert to co-write an article for him.

Development Consultant

I have sizable experience evaluating the viability of developing hillside projects in dodgy geological areas of Los Angeles County including Topanga and Malibu. I am able to uncover geological and permit problems, and their possible mitigation. Working with geologists, engineers, and specialized contractors, I have learned to exercise appropriate (perhaps even excessive) caution, despite the “sunny” pronouncements of unscrupulous real estate agents.

Esplanade Productions, Inc.

I have served as a secretary and chief financial officer of my husband’s loan out corporation, keeping after the bookkeeper and accountant and making sure they do their jobs effectively. I am solvent and have never been audited.

My work experience includes 26 years of critiquing the work of my well-known screenwriter husband, combining story editing, dialogue editing, concept vetting and research. My two bits have helped steer Big Trouble in Little China, Total Recall, Navy Seals, Minority Report and Next onto the screen.
