PROPOSED PROJECT: A 2-unit residential condominium with 2 covered parking spaces and one uncovered parking space per unit, for a total of six parking spaces, on a 4,950 net square-foot site.

REQUESTED ACTION: The Deputy Advisory Agency shall consider:

Pursuant to Section 17.50 of the Los Angeles Municipal Code (LAMC) consideration of a Preliminary Parcel Map for a one-lot subdivision.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

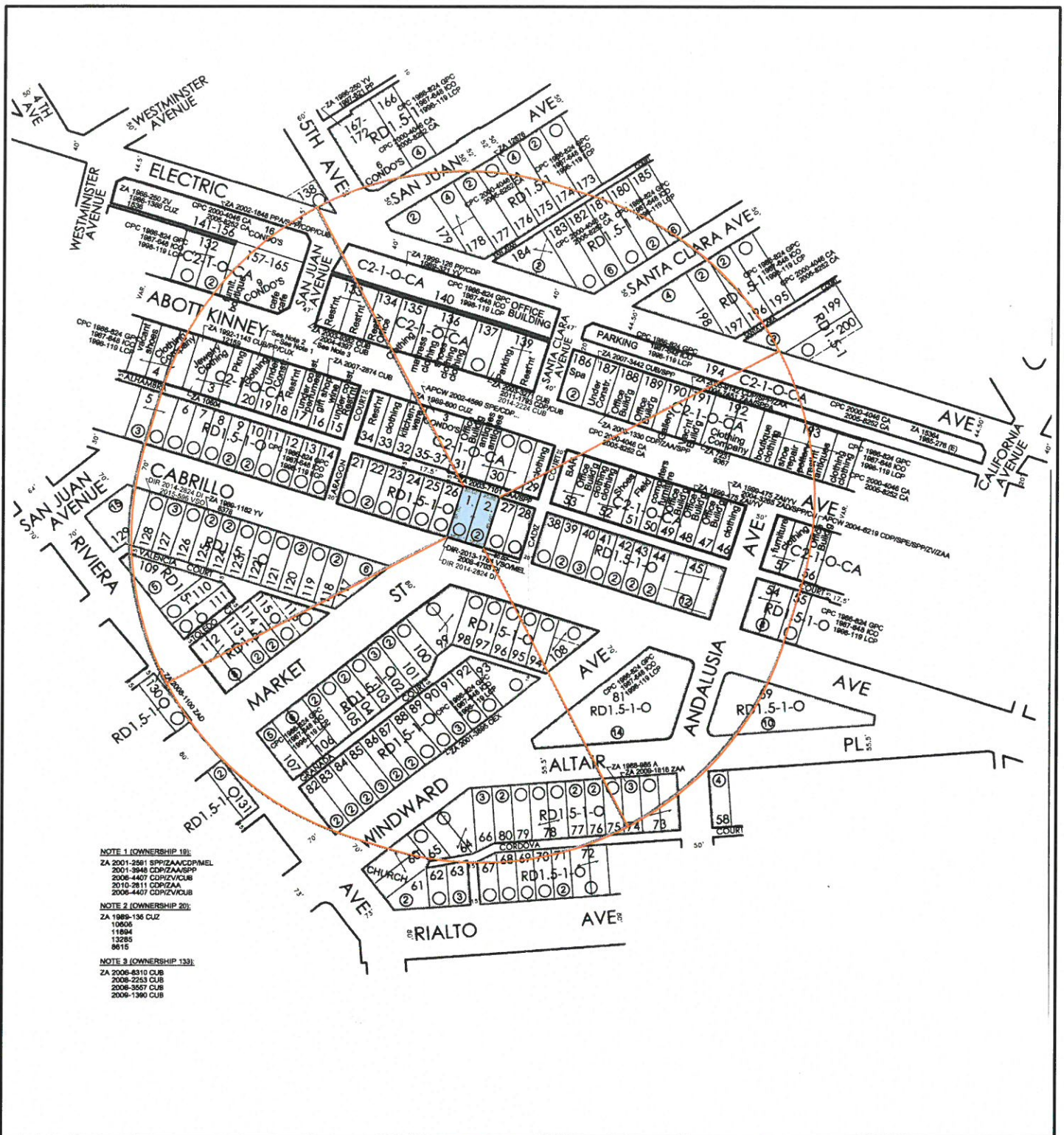
