**PROPOSED** 

PROJECT:

No change to the building is proposed. This involves a review of operations of a previously granted Conditional Use Permit for compliance of conditions relative to off-site alcoholic

beverage sales on an existing 93,818 square-foot Target Store commercial building, on a 4.06

acre lot.

**REQUESTED ACTIONS:** 

1) Pursuant to Los Angeles Municipal Code Section 12.24-M, a Conditional Use Plan Approval pursuant to Condition No. 9 of Case No. ZA-2011-2401-CUB-1A for review of the Petitioner's compliance with and the effectiveness of the CUP conditions, in the C4-2D-O Zone; and

2) Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
