PROPOSED PROJECT:

The subdivision of one lot into four (4) for the construction, use and maintenance of four (4) Small Lot Homes, 36 feet in height with 8 parking spaces on a 6,812.78 net square-foot (0.156 acre) site.

REQUESTED ACTION:

The Deputy Advisory Agency will consider:

- 1. Pursuant to the Los Angeles Municipal Code Sections 17.50 and 12.22-C,27, Parcel Map No. AA-2015-1710-PMLA-SL to permit the construction of four (4) new small lot homes with eight (8) parking spaces in accordance with the Small Lot Ordinance No. 176,354 on a net 6,812.78 square-foot site in the RD1.5-1XL Zone; and
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
