PROJECT LOCATION: 6643-6701 North Louise Avenue

PROPOSED PROJECT:

The proposed project involves the demolition of an existing single-family dwelling and detached garage and the subdivision, construction, use, and maintenance of eight (8) new single-family dwellings on a 51,418 net square-foot site in the RA-1-RIO Zone. Four dwellings will front Louise Avenue and four dwellings front Lasaine Avenue. The project will require a Zone Change from RA-1-RIO to R1-1-RIO and a building line removal.

REQUESTED ACTION:

The Deputy Advisory Agency will consider:

- 1. Pursuant to Section 17.03 of the Los Angeles Municipal Code, a Tentative Tract Map to allow for the merger and re-subdivision of two lots into eight lots.
- 2. Pursuant to Sections 21082.1(c)(3) and 21081.6 of the California Public Resources Code, adopt the Mitigated Negative Declaration (Case No. ENV-2016-0557-MND)

and Mitigation Monitoring Program for the above-referenced project;

On behalf of the South Valley Area Planning Commission, the Hearing Officer will consider:

- 1. Pursuant to LAMC Section 12.32-F a **Zone Change** from RA-1-RIO and R1-1-RIO;
- 2. Pursuant to LAMC Section 12.32-R, a **Building Line Removal** to remove a 28-foot Building Line along Louise Avenue, established under Ordinance No. 111,890;

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
