PROPOSED PROJECT: The proposed project includes development of the Project site with 42 two story single-family homes, one home per parcel. Each house would have 3-4 bedrooms and a two-car garage. The homes would range in size from approximately 1,729 square feet to 2,279 square feet. Of the 102 protected trees, 34 would be retained in place, and 68 would be removed. Of the 72 non-protected trees, eight would be retained in place, and 64 would be removed. All removed trees would be replaced in accordance with City requirements.

REQUESTED ACTION: Hearing Officer will consider:

1. Pursuant to Los Angeles Municipal Code Section 12.32, a Zone Change from the existing [Q]R1-1D and [Q]RD6-1D to [Q]RD5-1D.
2. Pursuant to Los Angeles Municipal Code Section 12.24 X.26, a Zoning Administrator Adjustment to allow multiple retaining walls instead of the two retaining walls permitted on a lot.
3. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, consider the Mitigated Negative Declaration (ENV-2015-1918-MND) and Mitigation Monitoring Program for the subject project.

The Deputy Advisory Agency will consider:

1. Pursuant to the Los Angeles Municipal Code Section (LAMC) 17.03 and Section 12.22-C, 27, a Vesting Tentative Tract Map 73531-SL to permit a small lot subdivision pursuant to Ordinance No. 176,354.
2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, consider the Mitigated Negative Declaration (ENV-2015-1918-MND) and Mitigation Monitoring Program for the subject project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations. After the hearing, the Hearing Officer will prepare a report, including a recommendation, which will be considered by the East Los Angeles Area Planning Commission at a later date. The Deputy Advisory Agency will review the project and issue a Determination Letter at a later date
