REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Los Angeles Municipal Code 12.24 M, an approval of plans to allow the continued sale and dispensation of a full line of alcoholic beverages on the 986 sq. ft. rear outdoor patio with 40 seats and 800 sq. ft. front outdoor patio with 22 seats of an existing 4,807 square-foot deemed to be approved restaurant. The proposed front patio hours are from 11:00 a.m. to 2:00 a.m., daily and the proposed rear patio hours are from 11:00 a.m. to 10:15 p.m., Sunday through Thursday and 11:00 a.m. to 11:15 p.m. Friday and Saturday.
2. Pursuant to Los Angeles Municipal Code 12.24-W, 27, a Conditional Use Permit to allow a closing time of 2:00 a.m., daily for the front patio and a closing time of 11:15 p.m., Friday and Saturday for the rear patio, in lieu of a closing time of 11:00 p.m. as restricted by Commercial Corner regulations.

3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice to Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
