**PROJECT LOCATION:** 533 North Lombard Avenue, legally described as: Lot 14, Block 17, Tract TR 9300

**PROPOSED PROJECT:** The demolition of an existing 1,577 square-foot one-story single-family dwelling and the construction of a new 2,992 square-foot two-story single-family dwelling on an 8,486 square-foot lot.

**REQUESTED ACTIONS:**

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for proposed demolition of an existing 1,577 square-foot one-story single-

family dwelling and the construction of a new 2,992 square-foot two-story single-family dwelling on an 8,486 square-foot lot within a Single Jurisdiction Area of the Coastal Zone.

2. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for the demolition and new construction of a Residential Unit in the Coastal Zone.
3. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration **ENV-2016-1854-MND** and corresponding Mitigation Monitoring Program for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
