PROJECT LOCATION: 330 South Mapleton Drive

REQUESTED ACTION: The Zoning Administrator will consider:

1. A Zoning Administrator's Adjustment per Section 12.28 of the Los Angeles Municipal Code to allow a rear yard of 24 feet 10 inches and side yard of 9 feet 6 inches in lieu of the 24-foot rear yard and 12-foot side yard otherwise required by Code Sections 12.21-C,5(e) and (f), and relief from Section 12.21,C-5(b) to allow an accessory building within 55-feet of the front lot line and within the front half of the lot, and to allow an accessory building to be located within 25-feet of one front lot line on a through lot as required by Section 12.21-C,5(K), all in conjunction with the conversion of an existing storage room into an accessory living quarter and recreation room.
2. Pursuant to Section 21804 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA pursuant to Article III, Section I, Class 3, Category 6 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda. Review Of File: The file, including the application and the environmental assessment, are available for public inspection at this location between the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday.
