PROJECT LOCATION: 742-746 Milwood Avenue

PROPOSED PROJECT: The renovation of an existing 2,352 square-foot single-family dwelling and addition of 2,448 square feet, and a new 638 square-foot detached recreation room, for a 4,802 square-foot 24-foot 8-inch tall single-family dwelling on two lots totaling 10,800 square feet in the R2-1 zone.

REQUESTED ACTION:

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the proposed renovation of an existing 2,352 square-foot single-family dwelling and addition of 2,448 square feet, and a new 638 square-foot detached recreation room, for a 4,802 square-foot 24-foot 8-inch tall single-family dwelling on two lots totaling 10,800 square feet within the single-permit jurisdiction of the California Coastal Zone.

2. Pursuant to Section 12.28 a **Zoning Administrator's Adjustment** to allow a 4-foot side yard setback in lieu of the required 5 feet pursuant to Section 12.08.C.2
3. Pursuant to Section 21084 of the California Public Resources Code and Article III Class 5 (Alterations in Land Use Limitations) Category 10 (Minor yard variances) of the City CEQA Guidelines, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
