DIRECTOR'S REPORT

Debbie Lawrence, Senior City Planner made the following announcements:

- On October 18, 2017, the Department of City Planning hosted the annual Planning Day. This year, it focused on South Los Angeles encompassing the Baldwin Hills, West Adams-Leimert and South Los Angeles and South East Los Angeles Community Plan Areas.
- On September 22, 2017, and pursuant to the voter approved Measure JJJ the Transit Oriented Community Affordable Housing Incentive Program became effective. The measure requires the Department of City Planning to create TOC Guidelines for all housing developments located within a half mile radius of a major transit stop.
- From July to mid-October, 30, 377 customers were served at the Development Center Public Counters and the West Los Angeles counter continues to be busy. The counter opened in April and served 22 customers. In August it served 1,176 customers.
- The Department of City Planning continues to hire new staff with more Planning Assistants coming on board before the end of the year.
- On October 3, 2017, the Planning and Land Use Management Committee voted in favor of the Mayor's appointment of Mrs. Heather E. Rozman of the West Los Angeles Area Planning Commission.
