**PROJECT SITE:** 1269-1279 North Lyman Place; 4576 West Fountain Avenue

### **PROPOSED PROJECT:**

Demolition of two existing duplexes, and a change of use from residential to an ancillary surface parking lot for use by the Hollywood Presbyterian Medical Center (HPMC), located within Subarea C (Community Center) of the Vermont/Western Station Neighborhood Area Plan (SNAP) Specific Plan.

Demolition of two existing duplexes, and a change of use from residential to an ancillary surface parking lot for use by the Hollywood Presbyterian Medical Center (HPMC), located within Subarea C (Community Center) of the Vermont/Western Station Neighborhood Area Plan (SNAP) Specific Plan.

- 1. Determine based on the whole of the administrative record that the Project is exempt from CEQA pursuant to State CEQA Guidelines, Article 19, Class 15301, Class 15311, and City's CEQA Guidelines, Article III, Section 1, Class 11, Category 2; and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
- 2. Deny the appeal and sustain the Planning Director's determination to approve a Project Permit Compliance Review with conditions for the demolition of two existing duplexes, and a change of use from residential to an ancillary surface parking lot for use by the Hollywood Presbyterian Medical Center, pursuant to LAMC Section 11.5.7 C and the Vermont/Western SNAP.
- 3. Adopt the Conditions of Approval and Findings by the Planning Director.
