The proposed project is the continued sale & dispensing of alcoholic beverages for on-site consumption within three (3) existing restaurants: a) Daily Grill: A full line of alcoholic beverages for on-site consumption in conjunction with a 4,216 square-foot restaurant space with 94 seats and a 950 square foot exterior patio with 56 seats. Hours of operation are from 11 a.m. to 12 midnight, daily; b) Tender Greens: Beer & Wine for on-site consumption in conjunction with a 3,026 square foot restaurant space with 77 seats and a 333 square foot exterior patio with 42 seats. Hours of operation are from 11 a.m. to 12 midnight, daily; and c) Mazza Modern Kitchen: A full line of alcoholic beverages for on-site consumption in conjunction with a 2,850 square-foot restaurant space with 82 seats and a 1,200 square foot exterior patio with 50 seats operated from 11 a.m. to 12 midnight, daily.

REQUESTED ACTION(S):

1. The Zoning Administrator shall consider an Exemption from CEQA pursuant to CEQA Guidelines Section 15301 and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies; and
2. Pursuant to Los Angeles Municipal Code Section 12.24-M, a Plan Approval to delete Condition No 8 of Case No ZA-95-0305-CUB-PA2 to extend the term of the grant, and to modify Condition No 10 of Case No ZA-95-0305-CUB-PA2 to authorize the sale and dispensing of alcohol beverages for on-site consumption within one (1) existing and two (2) new restaurants: a) Daily Grill: A full line of alcoholic beverages for on-site consumption in conjunction with a 4,216 square-foot restaurant space with 94 seats and a 950 square foot exterior patio with 56 seats. Hours of operation are from 11 a.m. to 12 midnight, daily; b) Tender Greens: Beer & Wine for on-site consumption in conjunction with a 3,026 square foot restaurant space with 77 seats and a 333 square foot exterior patio with 42 seats. Hours of operation are from 11 a.m. to 12 midnight, daily; and c) Mazza Modern Kitchen: A full line of alcoholic beverages for on-site consumption in conjunction with a 2,850 square-foot restaurant space with 82 seats and a 1,200 square foot exterior patio with 50 seats operated from 11 a.m. to 12 midnight, daily.

GENERAL INFORMATION

FILE REVIEW - The complete file will be available for public inspection by appointment only. Please email the staff identified on the front page, at least three (3) days in advance, to arrange for an appointment. **Files are not available for review the day of or day before the hearing.**

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to, or at the hearing. Any materials submitted to the Department become City property and will not be returned. This includes any correspondence or exhibits used as part of your testimony.

REQUIREMENTS FOR SUBMISSION OF MATERIALS - Written materials may be submitted prior to or during the hearing via email or by U.S. mail to the staff identified on the front of this notice. The case number must be written on all communications, plans and exhibits.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenzized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
