Strathmore Dr.) PRELIMINARY REVIEW** for a new 7-story, 85 foot in height, residential building with 37 units requesting on- and off-menu density bonus incentives for increased FAR, open space reductions, reduced parking, reduced side and rear yards, increased height, increased retaining walls, and modified open space location requirements. Next Scheduled Meeting is **April 21, 2021** (Pending submission of new cases).

\*The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter and jurisdiction of the DRB. Individual testimony within the public comment period shall be limited to three (3) minutes per person and up to ten (10) minutes per subject. However, the DRB chairperson has the discretion to modify the time allotted on each subject, to each speaker and the number of speakers per subject. Items may be called in any order at the discretion of the DRB chairperson.

Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Westwood Community Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department, the Planning Department Website, and at the appropriate Council Office(s).
