2. Deny, pursuant to Charter Section 562 and Section 12.27 of the Los Angeles Municipal Code, a Zone Variance from Section 12.17.6A.13(a) to authorize the use and maintenance of two spray

paint booths located less than 500 feet of an R zone, on property located within the M1 zone; and 3. Adopt the Amended Findings.
