PROJECT SITE: 1925 – 1929 Figueroa Street

PROPOSED PROJECT:

A new 100% commercial, five-story Porsche auto dealership structure, with parking at the roof level. The dealership will consist of a 20,034 square-foot showroom, 10,064 square-foot offices, 34,893 square-foot servicing area, 9,987 square-foot storage, and 6,004 square-foot back-of-house. The maximum floor area ratio of the Project is 1.47:1 and will not exceed 80,982 square feet of floor area. The second floor also houses parking. The third floor is dedicated to work stalls for servicing and the fourth, fifth, and roof levels are primarily parking, with small detailing bays on the fifth floor. Overall, the Project is 72 feet and 8 inches tall at its highest point. The Project will provide 157 total parking spaces.

APPEAL:

An appeal of the March 23, 2023, a Planning Director's Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to CEQA Guidelines Section 15032, and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA guidelines, Section 15300.2 applies;
2. Approved, pursuant to the Los Angeles Municipal Code (LAMC) Section 16.05, a development project which creates, or results in an increase of 50,000 gross square feet or more of nonresidential floor area; and
3. Adopted the Conditions of Approval and Findings.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
