## i. DIR-2022-8707-DRB-SPP-SPR, 2727 N Benedict Canyon Dr, APN 4382021006 (CD 5)-

The project proposes the remodel and addition of 2,355.7 square feet to an existing 15,849.4 square foot two-story single-family residence, totaling to 18,304.7 square feet and a height of 35.6 feet. It proposes the demolition of a swimming pool and the construction of a new smaller and shallower one in a different location. It proposes the addition of a new terraced landscape garden where the existing pool currently is. The project proposes a new landscaped motor court design in place of the existing flat graded motor court. The project also proposes the conversion of a portion of the existing residence to a three-car garage. The project is located in the Outer Corridor and is subject to the Baseline Hillside Ordinance adopted on March 17, 2017. It is downslope and visible from Mulholland Drive right-of-way. The project proposes 1,439 cubic yards f cut, 789 cubic yards of fill, 0 cubic yards of import, and 650 cubic yards of export grading.

## ii. ZA-2023-1549-ZAD-DRB-SPP-MSP-HCA, 4366 N Morro Dr, APN: 2172021057 (CD 3)-

The project proposes the construction of a new three-story single-family residence with three bedrooms and two and a half baths totaling to 2,041 square feet. It also includes a 177 square foot basement and an attached garage of 339 square feet. It includes the construction of an attached ADU of 997 square feet with two bedrooms and two bathrooms. It proposes the construction of two retaining walls with a maximum height of 10 feet and length of 74 feet. It will also include 6 parking stalls, 2 of which will be covered and 4 will be uncovered. The project is located in the Outer Corridor and is subject to the Baseline Hillside Ordinance adopted on March 17, 2017. It is downslope and not visible from Mulholland Drive. The project proposes 878 cubic yards of cut, 180 cubic yard of fill, 0 cubic yards of import, and 698 cubic yards of export grading. The project proposes the removal of 1 Oak tree to be cut down.

#### iii. DIR-2022-9281-DRB-SPP-SPR, 2424 N Briarcrest Rd, APN 4388015010, (CD 5)- Katy Young Yaroslavsky

The proposed project is the construction of a new 25-foot two-story single-family residence totaling 7,029 square feet, with a three-car garage of 646.79 square feet and a driveway on a lot of 40,498 square feet. The project also proposes 5,760.43 square feet of hardscape, including balconies, a swimming pool, pool equipment platform, and 460 square feet of a LID planter. The project is in the Outer Corridor and is subject to the Baseline Hillside Ordinance adopted on March 17, 2017. The project is upslope and visible from Mulholland Drive right-of-way. The project proposes 651 cubic yards of cut, 106 cubic yards of fill, 545 cubic yards of export, zero cubic yards of import grading. The project does not propose the removal of any protected or significant trees, and therefore no tree removal is approved.

#### iv. DIR-2022-9135-DRB-SPP-MSP, 2340 Outpost Dr, APN: 5549010002 (CD 4)- Raman

The proposed project is the remodel and addition of 1,120 square feet to an existing twostory single family residence of 2,795 square feet on a lot of 48,539. The project also proposes the construction of retaining wall with a maximum height of 12 feet, new landscaping, and hardscaping. The project is in the Outer Corridor and is subject to the Baseline Hillside Ordinance adopted on March 17, 2017. The project is downslope and visible from Mulholland Drive right-of-way. The project proposes 452 cubic yards of cut, 3 cubic yards of fill, 449 cubic yards of export, and zero cubic yards of import grading. The project does not propose the removal of any protected or significant trees and therefore no tree removal is approved.

Grading – Cut: 452 Cubic Yards (CUYD), Fill: 3 CUYD, Export: 449 CUYD, Import: 0 CUYD Related Environmental: ENV-2022-9136-EAF

**OPEN MEETINGS** - The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter jurisdiction of the DRB. The Chair of the DRB may allocate the number of speakers per subject, the time allotted on each subject, and the time allotted to each speaker. Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Mulholland Scenic Parkway Specific Plan Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public

Files are not available for review the day of the hearing.

**TESTIMONY AND CORRESPONDENCE** - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to, or at the hearing. Any materials submitted to the Department become City property and <u>will not</u> be returned. This includes any correspondence or exhibits used as part of your testimony.

**PERSONS WISHING TO PROVIDE PUBLIC COMMENT:** When the Agenda item you wish to speak on comes up, please press \*9 to 'raise your hand'. Following the item presentation, Board staff will unmute those wishing to provide public comment and those who have 'raised their hand'. When called upon, you can begin to provide public comment for your allotted time. Staff will track your allotted time and give you a warning before the end of your allotted time, subsequently re-muting your line when your allotted time has concluded. Should there be any questions from the Board or Planning staff requiring your response, you will again be unmuted.

**Requirements for Submission of Materials for Members of the Public.** Written materials may be submitted prior to the hearing via email to <u>Planning.MulhollandSPInfo@lacity.org.</u> Submissions on the day of the public hearing may not be more than two (2) written pages, including exhibits, and must include the case and agenda item number on the cover or first page of the attachment. Photographs do not count toward the page limitation. The submission must be provided to Planning staff prior to the start of the hearing.

**Non-Complying Submissions.** Submissions that do not comply with these rules will be stamped "File Copy. Non-complying Submission." Noncomplying submissions will be placed into the official case file, but they will not be delivered to or considered by the Board and will not be included in the official administrative record for the item at issue.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW** - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to California Code of Civil Procedure Section 1094.5, the petition became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

#### **Telecommunication Relay Services -**

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to- Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the CA is a telemarketer. If you hear, "Hello. This is the relay service..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
