### JOINT HEARING WITH THE HEARING OFFICER FOR THE AREA PLANNING COMMISSION

**APCW-2022-3115-DRB-SPP-SPE-CDP-MEL-HCA; ENV-2022-3116-CE (148 N. Chautauqua Boulevard) FINAL REVIEW** for the demolition of unpermitted structures and the construction of a new, two-story, 17-foot 4-inch tall, mixed-use structure comprised of 1,414.50 square feet of office use, two dwelling units with 6 vehicle parking spaces and 7 bicycle parking spaces at the ground level. The project will be approximately 3,470 square feet with a Floor Area Ratio of 0.75:1. The project

includes the installation of 11 new signs and grading/export of approximately 767 cubic yards of soil. (Applicant's Representative: Susan Steinberg, Howard Robinson & Associates)

\*The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter and jurisdiction of the DRB. Individual testimony within the public comment period shall be limited to three (3) minutes per person and up to ten (10) minutes per subject. However, the DRB chairperson has the discretion to modify the time allotted on each subject, to each speaker and the number of speakers per subject. Items may be called in any order at the discretion of the DRB chairperson.

Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Westwood Community Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department, the Planning Department Website, and at the appropriate Council Office(s).
