**DIR-2023-4450-DRB-SPP; ENV-2023-4451-CE (833, 835, and 837 North Via De La Paz) FINAL REVIEW** for the change of use from a 2,880 square-foot Church, Library, and Reading Room to a 1,487 square-foot retail use and 1,393 square-foot Medical Office in a multi-tenant commercial development. The project also involves a remodel of the façade with a new ADA ramp, storefront, and landscaping. The proposed project also involves six new signs for the proposed project totaling approximately 21 square feet of sign area. There are currently five existing parking spaces on site. The project proposes to replace one existing parking space with a new accessible parking space; the remaining three existing parking spaces will be maintained. (Applicant: Purna and Rajesh Chopra; Property Owner: 833-837 Via De La Paz LLC)

\*The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter and jurisdiction of the DRB. Individual testimony within the public comment period shall be limited to three (3) minutes per person and up to ten (10) minutes per subject. However, the DRB chairperson has the discretion to modify the time allotted on each subject, to each speaker and the number of speakers per subject. Items may be called in any order at the discretion of the DRB chairperson.

Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Westwood Community Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department, the Planning Department Website, and at the appropriate Council Office(s).
