3. Item 1 - Public Hearing

**CPC-2024-325-CU-MCUP-CUX-SPE-SPP-DRB-SPR-WDI (3701 – 3761 Stocker Street)** – REVIEW of entitlement for a new 5-acre, 222,156 square-foot motion picture production studio campus including the new construction of five buildings totaling 256,700 square-feet and a total Floor Area Ratio (FAR) of 1.16:1. The project includes four production sound stages of totaling

49,200 square-feet, 6,500 square-feet of back house space, 44,000 square-feet of production support office space, a 13,400 square-foot mill shop for set production, a 31,000 square-foot open plaza courtyard, 112,150 square feet of leasable commercial office space with conference rooms, 11,560 square feet of restaurant space, 300 square foot security building, 3,100 square-feet of dedicated campus management space, a 6-story parking building with 375 automobile parking spaces and 3,000 square-feet of ground level retail space (Applicant's Representative: Nichole Smith, Horizon Development + Entitlement)

Next meeting (pending submission of new casework): November 20, 2024

\*-The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter and jurisdiction of the DRB. Individual testimony within the public comment period shall be limited to three (3) minutes per person and up to ten (10) minutes per subject. However, the DRB chairperson has the discretion to modify the time allotted on each subject, to each speaker and the number of speakers per subject. Items may be called in any order at the discretion of the DRB chairperson.

Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Crenshaw Corridor Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department, the Planning Department Website, and at the appropriate Council Office(s). Should there be any questions from the Board or Planning staff requiring your response, you will again be unmuted.
