POLICY FOR DESIGNATED PUBLIC HEARING ITEM NO. 3.

All requests to address the Commission on public hearing items must be submitted prior to the Commission's consideration of the item.

TIME SEGMENTS noted * herein are approximate. Some items may be delayed due to length of discussion of previous items.

To ensure that the Commission has ample opportunity to review written materials, members of the public who wish to submit written materials on agendized items should submit them to the Commission Office, 200 North Spring Street, Room 272, Los Angeles, CA 90012, at least 10 days prior to the meeting at which the item is to be heard in order to meet the mailing deadline.

The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Policies and Procedures and provided that the Commission retains jurisdiction over the case..

AGENDAS are posted for public review in the Main Street lobby of City Hall East, 200 No. Main Street, Los Angeles, California, and are accessible through the Internet World Wide Web at **<http://www.lacity.org/pln/index.htm>**.

If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agendized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing.

If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

AN APPEAL of the Zoning Administrator's decision **1)** pursuant to Los Angeles Municipal Code Section 12.24-W,1, for the denial of a Conditional Use to permit the sale and dispensing of beer and wine only for off-site consumption, in conjunction with the proposed convenience store (7-Eleven); and **2)** pursuant to Los Angeles Municipal Code Section 12.24-W,27, for the denial of a Conditional Use authorizing commercial corner development to allow 24 hours of operation in lieu of the hours between 7 a.m. and 11 p.m.; and **3)** pursuant to Los Angeles Municipal Code Section 12.24-W,27, for the approval of a Conditional Use authorizing commercial corner development to allow the exterior walls and doors of a ground floor containing non-residential uses that front adjacent streets to consist of less than 50 percent transparent windows, as required in Section 12.22,A-23(a)(3); and a Conditional Use authorizing commercial corner development to allow deliveries to occur between the hours of 7 a.m. and 11 p.m., in lieu of the hours between 7 a.m. and 8 p.m. Monday through Friday, 10 a.m. and 4 p.m. on Saturdays and Sundays as required in Section 12.22,A-23(b)(3); all in conjunction with the proposed convenience store; and adopt the environmental clearance Mitigated Negative Declaration ENV-2008-1046-MND.
