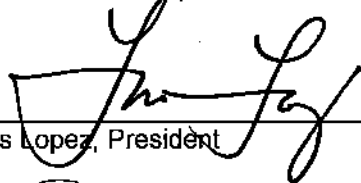
Staff presented information. Applicant and appellant both spoke.
