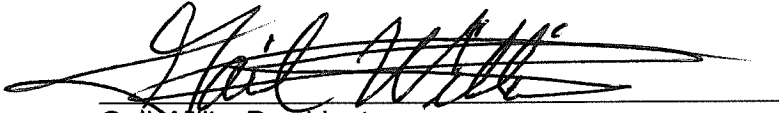
**3. Training on Findings**
