**REQUESTED ACTIONS:** The Zoning Administrator will consider:

 Pursuant to Section 12.20.2 of the Los Angeles Municipal Code (LAMC), a Coastal Development Permit for the construction of first- and second-floor additions totaling 840 square feet to an existing 3,927 square-foot two-story single-family dwelling and 545 square-foot two-car garage, swimming pool and spa, trellis, two 10-foot tall retaining walls, and shoring caissons for the retaining walls, all on a 20,900 square-foot lot within a Single Jurisdiction Area of the California Coastal Zone.

- 2. Pursuant to Section 21802.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration ENV-2015-1502-MND for the above-referenced project.
- Adopt the Mitigation Monitoring Program for ENV-2015-1502-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
