PUBLIC HEARING REQUIRED

PROJECT SITE: 912 East 60th Street

PROPOSED PROJECT:

The proposed project is a 15,917.7 square foot brewery, restaurant and entertainment venue, including a 12,400.8 square foot brewery within an existing building, 5,285.7 square foot brewery patio open to the sky, and the construction of a 3,204.3 square foot, two-story restaurant, including a 2,174.2 rooftop seating area and a 312.6 green room building. The proposed development will replace an existing furniture manufacture and storage facility with an industrial brewery, winery for wine and cider, and coffee roastery. The restaurant will include outdoor dining and large outdoor open assembly area, and stage. One existing shed building will be demolished and replaced with the proposed two-story restaurant building. Two parking spaces will be provided off-site, immediately adjacent to the project site and accessible from the rear alley. Bicycle parking will be provided off-site within a parking structure to be located within 50 feet of the primary entrance that will also provide shared surplus parking that will be available to patrons.

REQUESTED ACTIONS:

1. Pursuant to CEQA Guidelines Article 19, Section 15332 (Class 32), an exemption from CEQA, and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Pursuant to Section 12.24 W.1 of the Los Angeles Municipal Code (LAMC), a Conditional Use Permit to allow the sale and dispensing of a full line of alcohol sales for on-site consumption in conjunction with a restaurant and brewery and off-site sales of beer, wine and cider productions manufactured on-site, including use of a tasting room for beer, wine and coffee products;
3. Pursuant to LAMC Section 12.24 W.18, a Conditional Use Permit to allow live entertainment and dancing in conjunction with a restaurant;
4. Pursuant to LAMC Section 13.14 G.4, an exception to a regulation of the Southeast Los Angeles Community Plan Implementation Overlay, to allow a restaurant use in Subarea L, Industrial Innovation Subarea as otherwise prohibited by Section IV-1, A-1.b.(Table IV-2 Use Regulations); and
5. Pursuant to LAMC Section 13.14 G.4, an exception to a regulation of the Southeast Los Angeles Community Plan Implementation Overlay, to allow more than one establishment within a half mile radius of another Off-Site Alcohol Sales Use in Subarea L, Industrial Innovation Subarea as otherwise prohibited by Section IV-1, A-1.b.(Table IV-2 Use Regulations).

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the CA is a telemarketer. If you hear, "Hello. This is the relay service ... " when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
