Materials are to be emailed to apceastla@lacity.org. **Secondary Submissions** in response to a Staff Recommendation Report or additional comments must be received electronically no later than 48-hours before the Commission meeting. Submissions shall not exceed ten (10) pages, including exhibits, and must be submitted electronically to apceastla@lacity.org. Photographs do not count toward the page limitation. **Day of Hearing Submissions** within 24 hours of the meeting, up to and including the day of the meeting are limited to two pages plus accompanying photographs. Day of Hearing Submissions are to be submitted electronically to apceastla@lacity.org and 12 hard copies must be submitted at the in-person meeting. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission and will not be included in the official administrative record for the item at issue.

The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Rules and Operating Procedures and provided that the Commission retains jurisdiction over the case. If a Commission meeting is canceled or adjourned due to lack of quorum, all remaining agenda items shall be continued to the next regular meeting or beyond as long as the continuance is within the legal time limits of the case or cases.

PUBLIC HEARING REQUIRED

PROJECT SITE: 5027 East Almaden Drive

PROPOSED PROJECT:

Remodel and addition to an existing 1,068 square-foot, single-family dwelling. The Project includes a 1,202 square-foot second-story addition, 191 square-foot first-story addition, demolition of a 360 square-foot detached garage, and construction of a new 218 square-foot attached garage.

APPEAL:

An partial appeal of the September 30, 2024, Zoning Administrator's Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15303, Class 3 (New Construction or Conversion of Small Structures) and Section 15305, Class 5 (Minor Alterations in Land Use Limitations), and there is no substantial evidence demonstrating that any exceptions contained in Section 15300.2 of the State CEQA Guidelines regarding location, cumulative impacts, significant effects or unusual circumstances, scenic highways, or hazardous waste sites, or historical resources applies;
2. Approved, pursuant to Section 12.28 of the Los Angeles Municipal Code (LAMC), a Zoning Administrator's Adjustment to allow:
 - a. Westerly side yard setbacks of four feet five inches in lieu of the five feet otherwise required in conjunction with the construction, use, and maintenance of a second-story addition; and
 - b. An easterly yard setback of zero feet in lieu of the five-foot side yard otherwise required by LAMC Section 12.21 C.10(a) in conjunction with the construction, use, and maintenance of a semi-subterranean one-car garage;
3. Denied, pursuant to LAMC Section 12.28, a Zoning Administrator's Adjustment to allow:
 - a. A two-foot four-and-one-half-inch side yard setback in lieu of the otherwise required five feet pursuant to LAMC Section 12.21 C.10(a) in conjunction with the construction, use, and maintenance of a ground-floor addition to a proposed two-story dwelling;
 - b. A four-foot 10-inch easterly setback in lieu of the otherwise required five feet pursuant to LAMC Section 12.21 C.10(a), in conjunction with the construction, use, and maintenance of a second-floor addition to an existing one-story dwelling; and
 - c. A maximum residential floor area of 2,461 square feet in lieu of the otherwise permitted 2,252 square feet pursuant to LAMC Section 12.21 C.10(b) in conjunction with the construction, use, and maintenance of ground-level and second story additions to an existing single-family dwelling;
4. Dismissed without prejudice, pursuant to LAMC Section 12.28, a Zoning Administrator's Adjustment to allow a structure to exceed the Encroachment Plane height limitations of LAMC 12.21 C.10(d)(1)(ii), in conjunction with the construction, use, and maintenance of second-story additions to an existing single-family dwelling; and
5. Adopted the Conditions of Approval and Findings.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
