Every person wishing to address the commission in person must complete a speaker's request form and submit it to the Commission staff.

PUBLIC HEARING REQUIRED

PROJECT SITE: 3218 North Amethyst Street

PROPOSED PROJECT:

Construction, use, and maintenance of a new 25-foot five-inch, 1,607-square-foot single-family dwelling, including an attached one-car garage, a detached carport, and 92-square-foot covered patio on a vacant 4,164-square-foot lot (4,098-square-foot net). There are no protected trees on site or trees in the adjacent public right-of-way; one non-protected tree on site will be removed. The proposed Project is one of five abutting single-family dwellings being concurrently developed by the Applicant. ENV-2023-4108-CE analyzes all five single-family dwellings as one project under CEQA.

APPEAL:

An appeal of the August 25, 2025, Zoning Administrator's Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15332, Class 32 (In-fill Development), and there is no substantial evidence demonstrating that any exceptions contained in Section 15300.2 of the State CEQA Guidelines regarding cumulative impacts, significant effects or unusual circumstances, scenic highways, hazardous waste sites, or historical resources applies;
2. Denied, pursuant to Chapter 1, Section 12.24 X.28 of the Los Angeles Municipal Code (LAMC), a Zoning Administrator's Determination to permit the construction, use, and maintenance of a new single-family dwelling with an attached one-car garage, carport, and covered patio, on a lot fronting Substandard Hillside Limited Street, which is Amethyst Street, without providing a 20-foot-wide improved Minimum Adjacent Roadway as required by LAMC Code Section 12.21 C.10(i)(2);
3. Approved, pursuant to LAMC Chapter 1, Section 12.24 X.28, a Zoning Administrator's Determination to permit the construction, use, and maintenance of a new single-family dwelling with an attached one-car garage, carport, covered patio on a lot fronting a Substandard Hillside Limited Street, which is Amethyst Street, without providing a 20-foot-wide Continuous Paved Roadway from the driveway apron to the boundary of the Hillside Area as required by LAMC Chapter 1, Section 12.21 C.10(i)(3); and
4. Adopted the Conditions of Approval and Findings.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
