Every person wishing to address the commission in person must complete a speaker's request form and submit it to the Commission staff.

If staff is unable to establish a strong remote connection the in-person meeting shall continue to be conducted. **Applicants, Appellants, and/or Representatives are required to attend the meeting in person.**

Written submissions, which are optional, may be submitted prior to, or at, the meeting. These submissions are governed by the North Valley Area Planning Commission Rules and Operating Procedures posted online at <https://planning.lacity.org/commissioners>.

Initial Submissions, not limited as to volume, must be received by the Commission Executive Assistant no later than by 4:00 p.m. on the Monday prior to the week of the Commission meeting. **Secondary Submissions**, limited to ten (10) pages, must be received no later than 48 hours before the Commission meeting. **Day of Hearing Submissions**, limited to two (2) pages, are received within 48 hours of the meeting. All submissions should be made electronically to apcnorthvalley@lacity.org. Photographs do not count toward page limits. Submissions can be made until the Chair closes public comment on the agenda item. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission and will not be included in the official administrative record for the item at issue.

The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Rules and Operating Procedures and provided that the Commission retains jurisdiction over the case.

If a Commission meeting is canceled or adjourned due to lack of quorum, all remaining agenda items shall be continued to the next regular meeting or beyond as long as the continuance is within the legal time limits of the case or cases.

If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

PUBLIC HEARING – Completed October 28, 2025

PROJECT SITE: 9119 North De Soto Avenue

PROPOSED PROJECT:

Construction, use and maintenance of a 7,276 square foot express car wash to be operated from 7:00 a.m. to 9:00 p.m. daily. The Project includes a drive-through car wash tunnel, 32 vacuum stations, a pay station, four bicycle parking stalls, landscaping, signage including relocation of a pole sign, and a trash enclosure. The Project includes the excavation of approximately 300 cubic yards of soil.

REQUESTED ACTIONS:

1. Pursuant to CEQA Guidelines Section 15074(b), in consideration of the whole of the administrative record, including the Mitigated Negative Declaration, No. ENV-2024-494-MND ("Mitigated Negative Declaration"), all comments received, the imposition of mitigation measures and the Mitigation Monitoring Program prepared for the Mitigated Negative Declaration;
2. Pursuant to Section 12.32 F of the Los Angeles Municipal Code (LAMC), a Zone Change from MR2-1 and P-1 to (T)(Q)C2-1;
3. Pursuant to the LAMC Section 12.24 W.4, a Conditional Use to allow an Automotive Use (car wash) within the C2 Zone with the following waivers from the development standards and operating conditions of LAMC Section 12.22 A.28;
 - a. Hours of operation from 7:00 a.m. to 9:00 p.m., daily, in lieu of Monday through Friday, 7:00 a.m. to 7:00 p.m.; Saturday, 9:00 a.m. to 8:00 p.m.; and Sunday, 11:00 a.m. to 8:00 p.m. pursuant to LAMC Section 12.22 A.28(b)(5);
 - b. Relocation of an existing free-standing pole sign in conjunction with a Conditional Use pursuant to LAMC Section 12.22 A.28(a)(6)(i).;
 - c. Exterior walls and doors which are parallel to a street may consist of less than 50 percent transparent windows in lieu of at least 50 percent transparent windows pursuant to LAMC Section 12.22 A.28(a)(1);
 - d. Zero landscaped set back along the Nordhoff Street frontage in lieu of a minimum width of five feet of landscaping along all street frontages pursuant to LAMC Section 12.22 A.28(a)(9)(i); and
 - e. Loading off-site, in lieu of the requirement that all loading, including those of vehicles, occur on-site, pursuant to LAMC Section 12.22 A.28(b)(6).

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico, and the U.S. territories for local and/or long-distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Do not hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." When you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
