- i. **DIR-2025-2287-SPPC-DRB-MSP-HCA, 3150 N. Benedict Canyon Drive, APN: 4382-001-033 (CD 5)**

The project proposes the demolition of an existing 1,970 square-foot single-family home and 380 square-foot garage; and the construction of a new 9,023 square-foot single-family home with an attached 1,440 square-foot 3-car garage, 605 square feet of covered patio space, a 3,140 square-foot basement, 2,428 square-foot Accessory Living Quarters with an attached 3-car garage, two retaining walls of 10 feet, and two swimming pools. The project proposes to have a maximum envelope height of 25 feet on a lot of approximately 61,072 square feet. The project site is in the Outer Corridor and subject to the Baseline Hillside Ordinance. The project site is downslope and Visible from the Mulholland Drive right-of-way. The project proposes 820 cubic yards of cut, 125 cubic yards of fill, zero cubic yards of import, and 834 cubic yards of export grading. The project does not propose the removal of any trees.

8. Public Hearing: **New Cases-**
 - i. **DIR-2024-5122-DRB-SPPC-MSP-HCA, 6993 W. La Presa Drive, APN: 5549-014-012 (CD 4)**

The project proposes the demolition of an existing 1,235 square-foot single-family home and detached 400 square-foot garage; and the construction of a 4,961 square-foot single-family home with a detached 450 square-foot 2-car garage, a swimming pool, and two retaining walls that do not exceed 10 feet in height. The project proposes to have a maximum height of 28 feet on a lot of approximately 18,941 square feet. The project site is in the Outer Corridor and subject to the Baseline Hillside Ordinance. The project site is downslope and not Visible from the Mulholland Drive right-of-way. The project proposes 2,085 cubic yards of cut, 135 cubic yards of fill, zero cubic yards of import, and 1,950 cubic yards of export grading. The project does not propose the removal of any trees.

OPEN MEETINGS - The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter jurisdiction of the DRB. The Chair of the DRB may allocate the number of speakers per subject, the time allotted on each subject, and the time allotted to each speaker. Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Mulholland Scenic Parkway Specific Plan Design Review Board is a "legislative body" and must: 1. Conduct all quorum meetings in public; and 2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department and the Planning Department Website. Click on <https://planning.lacity.org/about/commissions-boards-hearings#boards>.

FILE REVIEW - The complete file is available for public inspection by appointment only. Please call (Jude Hernandez at 213-482-7076 or Tiffany Corrales at 213-682-6368) or email (Planning.MulhollandSPInfo@lacity.org), at least three (3) days in advance to assure that the files will be available. **Files are not available for review the day of the hearing.**

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to, or at the hearing. Any materials submitted to the Department become City property and will not be returned. This includes any correspondence or exhibits used as part of your testimony.

PERSONS WISHING TO PROVIDE PUBLIC COMMENT: When the Agenda item you wish to speak on comes up, please press *9 to 'raise your hand'. Following the item presentation, Board staff will unmute those wishing to provide public comment and those who have 'raised their hand'. When called upon, you can begin to provide public comment for your allotted time. Staff will track your allotted time and give you a warning before the end of your allotted time, subsequently re-muting your line when your allotted time has concluded. Should there be any questions from the Board or Planning staff requiring your response, you will again be unmuted.

REQUIREMENTS FOR SUBMISSION OF MATERIALS – To ensure that the Design Review Board has ample opportunity to review written materials, members of the public who wish to submit written materials on agenda items should comply with the following:

Requirements for Submission of Materials for Members of the Public. Written materials may be submitted prior to the hearing via email to Planning.MulhollandSPInfo@lacity.org. Submissions on the day of the public hearing may not be more than two (2) written pages, including exhibits, and must include the case and agenda item number on the cover or first page of the attachment. Photographs do not count toward the page limitation. The submission must be provided to Planning staff prior to the start of the hearing.

Non-Complying Submissions. Submissions that do not comply with these rules will be stamped "File Copy. Non-complying Submission." Noncomplying submissions will be placed into the official case file, but they will not be delivered to or considered by the Board and will not be included in the official administrative record for the item at issue.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenda itemized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

Accommodations - As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability. Telecommunication Relay Services -

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to- Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the CA is a telemarketer. If you hear, "Hello. This is the relay service..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
