Written submissions, which are optional, may be submitted prior to, or at, the meeting. These submissions are governed by the West Los Angeles Area Planning Commission Rules and Operating Procedures posted online at <https://planning.lacity.org/commissioners>. **Initial Submissions**, not limited as to volume, must be received by the Commission Executive Assistant no later than by 4:00 p.m. on the Monday prior to the week of the Commission meeting. **Secondary Submissions**, limited to ten (10) pages, must be received no later than 48 hours before the Commission meeting. **Day of Hearing Submissions**, limited to two (2) pages, are received within 48 hours of the meeting. If the submission is made on the same day as the meeting, it is recommended that ten (10) hard copies of the submissions be brought to the meeting for distribution to Commissioners. All submissions should be made electronically to apcwestla@lacity.org. Photographs do not count toward page limits. Submissions can be made until the Chair closes public comment on the agenda item. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission and will not be included in the official administrative record for the item at issue.

The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Rules and Operating Procedures and provided that the Commission retains jurisdiction over the case.

PROJECT SITE: 13374 West Jefferson Boulevard

Planning staff is requesting that the matter be continued.

PROPOSED PROJECT:

The plugging and abandonment of the natural gas well Vidor 15 (API: 0403714071) at the Playa Del Rey Natural Gas Storage Facility, located within an upland area of the Ballona Wetlands Ecological Reserve. Work would include use of a workover rig to remove piping and the wellhead, setting cement plugs, cutting the top portion of the well casing, sealing the well, and including identifying information. Mechanical Integrity Testing (MIT) may also be required depending on guidance from CalGEM.

APPEAL:

An appeal of the October 24, 2025, Director of Planning Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15301, (Class 1 - Existing Facilities); Section 15304, (Class 4 - Minor Alterations to Land); and Section 15308, (Class 8 - Actions by Regulatory Agencies for Protection of the Environment) and that there is no substantial evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Approved, pursuant to Chapter 1A Section 13B.9.1 of the Los Angeles Municipal Code, a Coastal Development Permit for the proposed project, located in the Dual Permit Jurisdiction Area of the Coastal Zone; and

PROPOSED PROJECT:

Sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a proposed 4,618 square-foot restaurant with 142 indoor seats and 106 outdoor seats in the public right-of-way in the C2-1XLD Zone. Hours of operation from 10:00 a.m. to 2:00 a.m. daily for indoor seating in conjunction with a proposed restaurant in lieu of the limited hours of operation of 7:00 a.m. to 11:00 p.m. for Commercial Corner Developments and Mini-Shopping Centers.

APPEAL:

An appeal of the February 20, 2026, Zoning Administrator's Determination which:

1. Determined, based on the whole of the administrative record, that the Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15303, Class 3, and there is no substantial evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Approved, pursuant to Chapter 1 Section 12.24 W.1 and Chapter 1A Section 13B.2.2 of the Los Angeles Municipal Code (LAMC), a Class 2 Conditional Permit to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a proposed restaurant in the C2-1XLD Zone;

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico, and the U.S. territories for local and/or long-distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Do not hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." When you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
