Every person wishing to address the commission in person must complete a speaker's request form and submit it to the Commission staff.

Initial Submissions, not limited as to volume, must be received by the Commission Executive Assistant no later than by 4:00 p.m. on the Monday prior to the week of the Commission meeting. **Secondary Submissions**, limited to ten (10) pages, must be received no later than 48 hours before the Commission meeting. **Day of Hearing Submissions**, limited to two (2) pages, are received within 48 hours of the meeting. If the submission is made on the same day as the meeting, it is recommended that twelve (12) hard copies of the submissions be brought to the meeting for distribution to Commissioners. All submissions should be made electronically to cpc@lacity.org. Photographs do not count toward page limits. Submissions can be made until the Chair closes public comment on the agenda item. Submissions that do not comply with these rules will be stamped "**File Copy. Non-Complying Submission.**" Non-complying submissions will be placed into the official case file, but they will not be delivered to or considered by the Commission and will not be included in the official administrative record for the item at issue.

The Commission may RECONSIDER and alter its action taken on items listed herein at any time during this meeting or during the next regular meeting, in accordance with the Commission Rules and Operating Procedures and provided that the Commission retains jurisdiction over the case.

PUBLIC HEARING – Completed August 14, 2026

PROJECT SITE: 4127 East Supreme Court
(4127 – 4129 East Supreme Court; 4127 – 4129 North Mission Road)

PROPOSED PROJECT:

Demolition of the existing billboard structure on a 4,500-square-foot lot and the construction, use, and maintenance of a new, six-story 13-unit apartment building with two units reserved for Very Low-Income Households. The Project will include 13 one-bedroom units which will range from 532 square feet to 562 square feet. The building will have 9,499 square feet of floor area and a maximum building height of 78 feet. The Project will provide 1,105 square feet of open space consisting of a community room and rooftop open space.

The Project is eliminating required automobile parking spaces pursuant to California Government Code Section 65863.2 (AB 2097) and will provide 11 automobile parking spaces on the ground floor and a total of 17 bicycle parking spaces (15 long-term and two short-term). The Project also proposes to provide six new trees and to import approximately 215 cubic yards of earth materials.

REQUESTED ACTIONS:

1. Pursuant to California Environmental Quality Act (CEQA) Guidelines Article 19, Section 15332 (Class 32), an exemption from CEQA and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
2. Pursuant to Chapter 1 Section 12.22 A.25(g) of the Los Angeles Municipal Code (LAMC), a Density Bonus for a Housing Development Project consisting of a new six-story, 13-unit apartment building with two units reserved for Very Low-Income households, and requesting the following Off-Menu Incentives and Waivers of Development Standards:
 - a. An Off-Menu Incentive for a 5.6 percent reduced rear yard setback of 17 feet in lieu of the 18 feet required per LAMC Chapter 1 Section 12.14 C.2;
 - b. An Off-Menu Incentive for a 15.0 percent reduced open space of 1,105 square feet in lieu of the 1,300 square feet required per LAMC Chapter 1 Section 12.21 G.2;
 - c. An Off-Menu Incentive for a 100 percent reduced north side yard setback of zero feet in lieu of the required nine feet per LAMC Chapter 1 Section 12.14 C.2;
 - d. An Off-Menu Incentive for relief from Ordinance 173,070 (Subarea 7075A) to permit 100 percent residential development in lieu of prohibiting 100 percent residential development;
 - e. A Waiver of Development Standards to permit a zero-foot south side yard setback in lieu of the required nine feet per LAMC Chapter 1 Section 12.14 C.2;
 - f. A Waiver of Development Standards to permit zero-foot landscaped setbacks in lieu of the required five-foot landscaped setbacks (Commercial Corner Development) per LAMC Chapter 1 Section 12.22 A.23(a)(10)(i);

- g. A Waiver of Development Standards to permit a maximum building height of 78 feet, in lieu of a maximum of 25 feet and 33 feet (Transitional Height) as required per LAMC Chapter 1 Section 12.21.1 A.10;
- h. A Waiver of Development Standards to permit a maximum building height of 78 feet, in lieu of a maximum of 45 feet (Commercial Corner Development) as required per LAMC Chapter 1 Section 12.22 A.23(a)(1); and
- i. A Waiver of Development Standards to permit a 41.4 percent increase in the Floor Area Ratio (FAR) to allow 2.12:1 in lieu of the 1.5:1 permitted in a commercial zone in Height District 1 per LAMC Chapter 1 Section 12.21.1 A.1.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service ..." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.
