Item 5: 1851-1855 S Barry Ave

Appellant Edna Alvarez indicated that she reached a settlement agreement with the applicant this week. I have not been able to reach the other two appellants.

Item 6: 7366 S Osage Ave

This project is the culmination of over two years of extensive outreach by the applicant. The applicant won the support of the neighborhood council for these key reasons:

1. **Low Traffic Impact** - the self-storage use was preferred for its very low traffic compared with other uses
2. **Community Benefits** - the facility will incorporate a community art gallery
3. **Iconic Design** - the project features a striking, landmark design by a Pritzker Prize winning architect

For these reasons, Councilmember reiterates his continued support for the project.
