I write on behalf of Rabbi Kalmenson and Beis Medrash of Hancock Park (the "Applicant") in connection with the above-referenced matter, which is currently scheduled for hearing before the Central Area Planning Commission on June 23, 2026. My firm has recently been retained as counsel for the Applicant in this proceeding.

I am writing to respectfully request a continuance of the appeals hearing and, if possible, that it be rescheduled to August 25, 2026. This additional time would allow the Applicant to continue engaging constructively with the appellants and other neighbors and their representative in an effort to reach a mutually agreeable resolution of the issues raised in the appeals.
