1045 Olive, LLC (Applicant) proposes the construction of a new mixed-use development on an approximately 0.96-acre site located at the northwest corner of Olive Street and 11th Street (Project Site). Five existing single story commercial buildings containing 35,651 sf would be removed and replaced with a new 751,777 sf mixed-use high-rise building (Project). The Project would include a maximum of 794 residential units and 12,504 sf of neighborhood serving commercial uses located at the ground and mezzanine levels. The development would include a 61-story tower above a nine-story podium structure for a total of 70 floors, up to 810 feet in height. The Project would also include a public plaza and amenity/open space areas for its residents located above the podium, at mid-tower, on a roof terrace, and within private balconies.
