This is to advise that, on April 8, 2024, the Director of Planning approved with conditions a Project Permit Compliance to replace an existing Arena Freeway Sign with an updated Arena Freeway Sign, comprised of two Digital Displays and two wall sign components, with a combined signage square footage of 7,486 square feet and maximum height of 150 feet. The Director found based on the independent judgment of the decision-maker, after consideration of the whole of the administrative record, the Project was assessed in the Convention and Event Center Project Environmental Impact Report (EIR) No. ENV-2011-585-EIR (SCH No. 2011031049), certified in October 2012, and pursuant to CEQA Guidelines, Sections 15162 and 15164 and Addendum and Joint Analysis, dated December 2021, that no major revisions are required to the EIR and no subsequent EIR or negative declaration is required for approval of the Project.
