This is to advise that on **February 6, 2025**, the Director of Planning approved with conditions a Sign Application Compliance for four pedestrian-scale sign towers, with two 300 square-foot sign faces with Electronic Message Display Signs on each tower for a total of 2,400 square feet of sign area, located within the Eleventh Street Pedestrian Plaza within Sign District A-1. The Director found based on the independent judgment of the decision-maker, after consideration of the whole of the administrative record, the project was assessed in the Los Angeles Sports and Entertainment District Environmental Impact Report (EIR) ENV-2000-3577-EIR, certified in September 2001, and pursuant to CEQA Guidelines 15162 and 15164, and the Addendum and Joint Analysis dated December 2021, that no major revisions are required to the EIR and no subsequent EIR or negative declaration is required for approval of the project.
