PROJECT NAME: Housing Element 2021-2029 Update and Safety Element Update

Notice is hereby given that the City of Los Angeles, as the Lead Agency, has completed the Final Environmental Impact Report (FEIR) for the Housing Element 2021-2029 Update and Safety Element Update, and amendments to the Plan for a Healthy LA (Health Element). The FEIR includes a response to comments, modifications, and technical refinements to the Proposed Project, including supplemental analysis, and corrections and additions to the Draft EIR, and a Mitigation Monitoring Program (MMP).

PROJECT LOCATION: The Los Angeles Citywide Housing Element 2021-2029 Update, Safety Element Update ("Project"), and amendments to the Health Element will apply to the entire geographic area located within the boundaries of the City of Los Angeles (City).

Additional hearings by the decision-maker may occur, including a hearing by the full City Council, but are not scheduled at the time of publication of this notice. Please note comments on the Final EIR are not required to be responded to by the City. If written comments are received, they will be provided to the decision-maker for consideration.
