Major Projects should work with the City Attorney's Office request that ITA perform an email search for those custodians who fail to identify, label and download emails pursuant to these instructions.

The Lead Planner shall provide City staff with the specific Gmail label they are to use, as well as search terms City staff should use to find relevant, project-related emails. City staff will then apply the provided Gmail label to those emails. Email search terms will generally consist of the ENV, CPC, and/or Council file numbers for the project, project site address(es), and frequently used acronyms and shorthand names.
