I am aware that these projects were filed prior to engaging in early consultation. They were all subsequently put on hold until such time that the applicant met with RAP. I have actively been working with RAP and Planing staff and am in attendance at all the early consultation meetings. I've also had conversations with both Ralph Avila and Maritza Przekop, Senior City Planners for the public counters at Metro and Valley/West LA, respectively. All counter staff has been trained to not allow applicants to file a tract or parcel map with 50 or more units unless they have a verification letter from RAP on hand.

I'm confident that there will not be any future filings that slip through the cracks.
