- one-time contribution of \$1.6 million to Caltrans to implement ramp metering upgrades

- \$2.4 million to Caltrans to fund a portion of the improvement to add an auxiliary lane on the 101 freeway

- work with Caltrans on the design and implementation of traffic management measures that are coordinated and integrated with traffic management plans led by LADOT, Metro & LAPD for events
