Thanks for taking my call earlier this afternoon.

As we discussed, the LADOT assessment letter for the 1360 Vine Street project currently says that the project would contribute up to \$450,000 towards ATSAC system upgrades along the following corridors: De Longpre Avenue from Cahuenga Boulevard to Wilcox Avenue, Wilcox Avenue from De Longpre Avenue to Sunset Boulevard, Sunset Boulevard from Wilcox Avenue to Gower Street, Gower Street from Sunset Boulevard to Hollywood Boulevard, and Hollywood Boulevard from Gower Street to Highland Avenue.

We propose to divide this improvement into two parts, with part assigned as mitigation to the Hollywood Center project, as follows:

- 1360 Vine: De Longpre Avenue from Cahuenga Boulevard to Wilcox Avenue, Wilcox Avenue from De Longpre Avenue to Sunset Boulevard, and Sunset Boulevard from Wilcox Avenue to Gower Street
- Hollywood Center: Gower Street from Sunset Boulevard to Hollywood Boulevard, and Hollywood Boulevard from Gower Street to Highland Avenue

This division more equitably distributes the improvements based on where the two projects have significant intersection impacts (1360 Vine impacts along Sunset and Hollywood Center impacts along Hollywood). Is it correct to assume that the cost would be divided proportionally to the lengths of the two sections? Please confirm the cost breakdown.

Also, please ask ATSAC whether there are any other improvements they are looking for in the Hollywood area. Thanks!
