I believe the feasibility is there. At this point, we just wait for their official submittal to review. This is of course, after they secure a signed TCR from Bhuvan.

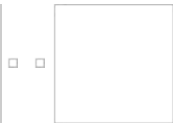

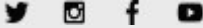

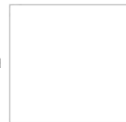
