Scenarios	HH VMT Per Capita	Work VMT Per Emp	Daily Trips	Daily VMT
Res Scenario	4.9	4.3	3,961	24,686
Hotel Scenario	4.9	5.1	4,596	29,068

There are minor changes to per capita VMT, daily trips, and daily VMT, and no impact.
