We have a couple questions and are hoping you can help:

1) Re: Millennium study(ENV-2018-2116-EIR)

What traffic study methodology will be used in the EIR relative to the 101 freeway and on/off ramps? We were assuming you would be following CalTrans' advisement per the 2011 "Millennium Hollywood" development (their previous letters are attached here for specifics). But there are rumors that these may be disregarded in favor of citylevel methodology. Can you please let us know what the intention is for the DEIR, and if there is any reason why

you would not include CalTrans' preferred methodology for freeway-related traffic issues?
2) Re: A Different Project — If a project has been proposed in our area — in this case, a change in business type requiring changes to physical structure and traffic easements— how do we keep tabs on it? We don't know if it is (or will be) going through an EIR, traffic study, etc. Can this info be gleaned online somehow — perhaps by owner's name or business address? We have some big potential traffic concerns, but we don't have an EIR number, nor any idea where to send our concerns.
