Hi Luci,

Hollywood Wilcox was published on February 27, 2020. The DEIR comment period ends April 13, 2020.

The timeline for the FEIR and subsequent hearings is dependent on the number of comments received on the DEIR.

That said, the FEIR should be released no later than late summer, with a worst case scenario of fall for CPC/PLUM. If there are few comments on the DEIR, the FEIR and entitlement timeline can be pushed up accordingly. As we are already near the middle of the comment period, we should have a relatively workable timeline to be approved by council prior to the ELDP expiration date.

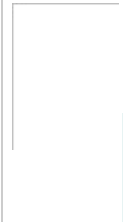
