Thank you for the quick turnaround. Through recent conversations with LADOT, it was confirmed that assignment of direct and cumulative trips to state facilities in the project vicinity as well as an off-ramp queuing analysis would be considered under the non-CEQA transportation analysis. Milena thought this might be prudent to mention to you in case we wanted to include that, while it is not under the purview of the CEQA analysis, that the non-CEQA analysis would address these concerns.
