The proposed haul route is as described below:

FROM - (Address) 1720-1770 North Vine Street; 1746-1760 North Ivar Avenue; 1733 and 1741 Argyle Avenue; 6236, 6270, 6334 West Yucca Street; Los Angeles, CA 90028.

TO - (Address) Waste Management- Azusa Land Reclamation, 1211 West Gladstone Street, Azusa, CA 91702

LOADED TRUCKS – **1<sup>st</sup> option:** Travel along Ivar Avenue and Vine Street to Yucca Street. Outbound trucks would travel east on Yucca Street, north on Argyle Avenue, and enter the US-101 southbound on-ramp just north of Yucca Street. 2<sup>nd</sup> option: Travel along Ivar Avenue and Vine to Yucca Street to Vine Street. Outbound trucks would travel south on Vine Street, east on Hollywood Boulevard for approximately 0.5-miles and enter the US-101 southbound on-ramps.

EMPTY TRUCKS – **1<sup>st</sup> option:** Head north on US-101 to take the Gower Street off-ramp, head south on Gower Street, west on Yucca Street, and south on Vine Street and Ivar Street. 2<sup>nd</sup> option: Head north or south on US-101 to take the Hollywood Boulevard off-ramp, head west on Hollywood Boulevard, and north on Ivar Street or north on Vine Street.

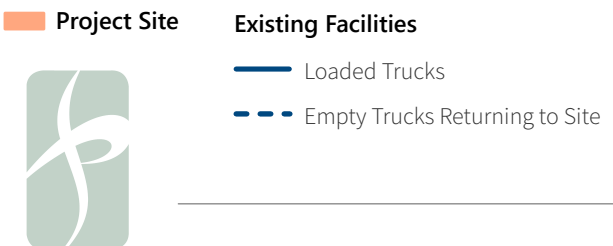
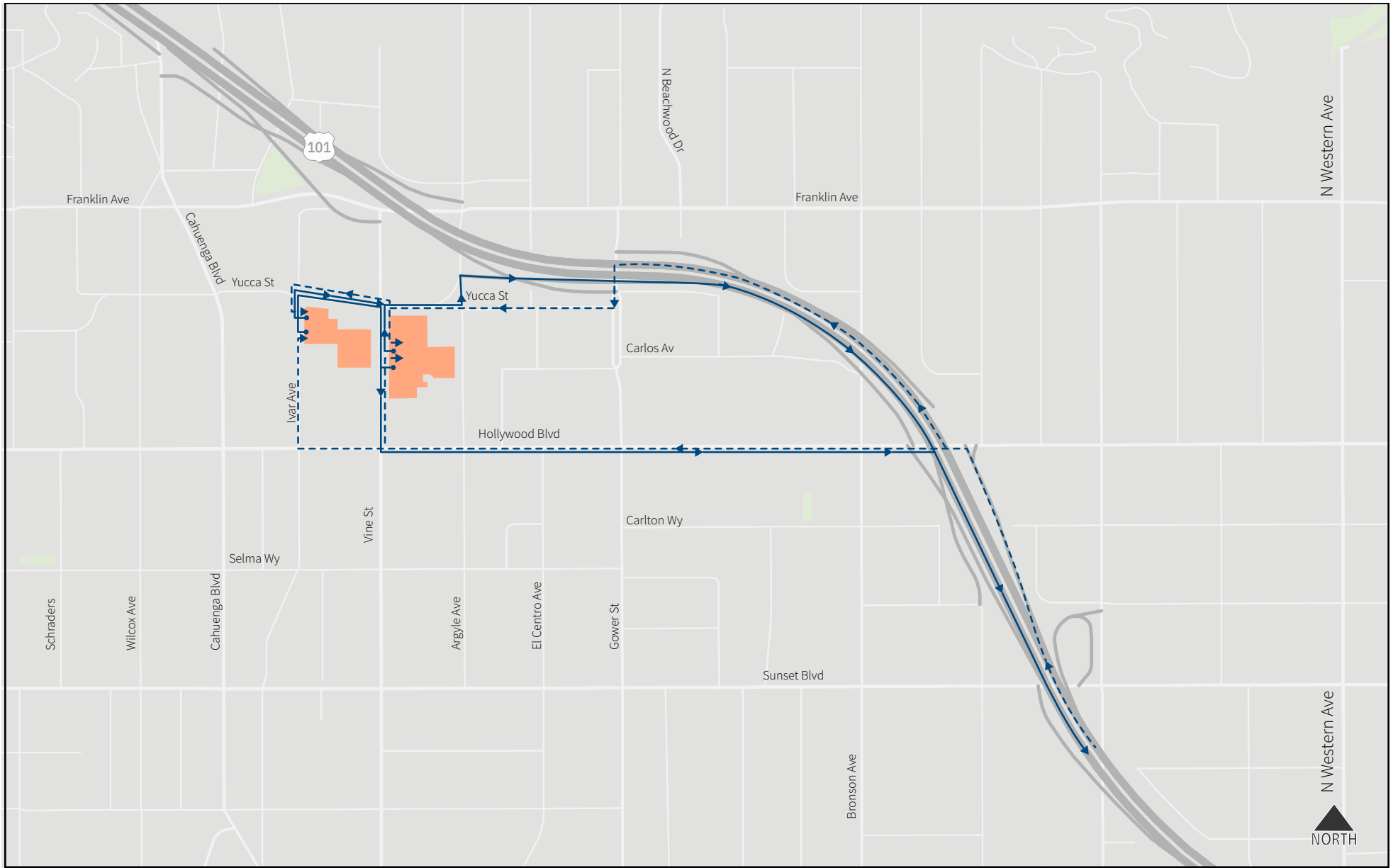
