South Coast AQMD staff is in the process of reviewing the Draft Environmental Impact Report (Draft EIR) for the Proposed Hollywood Center Project (South Coast AQMD Control Number: LAC200416-01). The public commenting period is from 04/16/2020 – 06/01/2020.

Upon review of the information on the City's website as a part of the public review period, I was able to access PDF versions of the CalEEMod runs and HRA Worksheets and Output Files available in Appendices E-1 and -2. However, I was unable to access any live modeling input files used to generate the CalEEMod and AERMOD runs or any live output files from the various runs.

Please provide an electronic copy of the live modeling files that were used to generate CalEEMod and AERMOD runs (e.g., live input files), any live output files, and any additional emission calculation spreadsheets used to quantify the air quality impacts, including health risk, from construction and/or operation of the Proposed Project.
