Hi John,

The public hearing will take place on August 26, 2020, as originally scheduled. However, the City is still working on the FEIR and it is not available at this time. That being said, the Vesting Tentative Tract case will be taken under advisement and no action will be taken until the FEIR has been made available for a minimum of 10 days, pursuant to CEQA Guidelines Section 15088. A Notice of Availability of the Final EIR will be provided to all interested parties and commenters on the Draft EIR once it is available. As you provided comments on the Draft EIR, you will be receiving a Notice.

Please note that we will still be collecting public testimony on both the VTT and CPC cases.
